#### **General Business**

- Last competition lunch was provided for all competitors, helper, judges and committee to
  encourage club cohesiveness. It was well received and provided a forum for discussion re
  Hendra policy. The outcome of the discussion was a suggestion for 3 day temperature logs
  prior to arrival &/or a waiver to be signed by owners of unvaccinated horses. KT to follow up
  with appropriate people.
- KT drafted a waiver and sent it to Gow Gates 14/3/16 for review by legal department (contact Will MacArthur: equestrian@gowgates.com.au). Still waiting for response
- KT rang Paul Freeman (CVO DPI NSW) re quarantining questions. Outcome as follows:
  - In the event of a suspected Hendra case at a competition- vaccinated horses go home
  - DPI covers cost of PPE and pathology
  - Horse owners cover all other expenses involved in keeping a horse in quarantine (food, accommodation for owner, horse food, other veterinary costs, etc)
  - Probably no value in 3 day temperature logs in detecting Hendra risk (horses can be be contagious for 72 hours before showing any symptoms including fever)
  - o A 5 metre exclusion zone from horses should protect from droplet spread
- Discussion ensued re exclusion zone for judges, a rail on cones set at the 5 metre points on the arena at judges end going back should provide a visible barrier and keep judges safe. Judge parks in the middle at C.
- Need to talk to Sheila about best way to keep gear/ warmup area steward safe.
- Next competition: leave conditions as is until we get response from insurance company

Risk Management: as per previous discussion re Hendra.
